Upon consideration of the motion for summary affirmance, the opposition thereto, and the reply, it is

**ORDERED** that the motion for summary affirmance be granted. The merits of the parties' positions are so clear as to warrant summary action. See Taxpayers Watchdog, Inc. v. Stanley, 819 F.2d 294, 297 (D.C. Cir. 1987) (per curiam). The district court correctly dismissed appellant's complaint for lack of standing. See Campaign Legal Ctr. v. FEC, 860 F. App'x 1, 4 (D.C. Cir. 2021) (per curiam) ("[A]n interest in proper administration of the laws (specifically, in agencies' observance of a particular statutorily prescribed procedure) is a generic interest in good government that is shared equally by all citizens and does not amount to a concrete or particularized Article III injury"); Common Cause v. FEC, 108 F.3d 413, 419 (D.C. Cir. 1997) (per curiam) (holding the Federal Election Campaign Act's citizen-suit provision "does not confer standing; it confers a right to sue upon parties who otherwise already have standing").
