SOUTH DAKOTA DEMOCRATIC PARTY (SDDP) (A11-20)

Memorandum from the Chief Compliance Officer and Audit Division dated January 29, 2015

Chair Ravel recognized Mr. Jim Miller of the Audit Division who summarized the five Findings in the Memorandum: 1) misstatement of financial activity; 2) recordkeeping for employees; 3) reporting of coordinated party expenditures; 4) contributions from unregistered political organizations; and 5) disclosure of occupation/name of employer.

Chair Ravel recognized Commissioner Weintraub who

MOVED to approve Finding 1 (Misstatement of Financial Activity), Finding 3 (Reporting of Coordinated Party Expenditures), Finding 4 (Contributions from Unregistered Political Organizations), and Finding 5 (Disclosure of Occupation/Name of Employer) as set forth in Agenda Document No. 15-11-A.

The motion carried by a vote of 6-0 with Commissioners Goodman,

Hunter, Petersen, Ravel, Walther, and Weintraub voting affirmatively for the decision.

Chair Ravel recognized Commissioner Weintraub who

MOVED to approve Finding 2 (Recordkeeping for Employees) as set forth in Agenda Document No. 15-11-A subject to an amendment to include the \$17,770 paid to contract workers.

The motion failed by a vote of 3-3 with Commissioners Ravel, Walther, and Weintraub voting affirmatively for the motion. Commissioners Goodman, Hunter, and Petersen dissented.

Chair Ravel recognized Commissioner Weintraub who

**MOVED** to take the following actions:

- 1. Approve Finding 2 (Recordkeeping for Employees) as set forth in Agenda Document No. 15-11-A related to the \$42,557 that the committee disclosed as having been paid with an allocation of federal and non-federal funds and \$2,399 that was paid from an exclusively non-federal account during the periods in which the employee was also paid with federal funds.
- 2. Direct the Audit Division to include in the Proposed Final Audit Report an Additional Issues section addressing the \$15,187 for 100% non-federal payments.
