Chairman Petersen recognized Commissioner Goodman who said that he would cede to Commissioner Weintraub's desire not to proceed seriatim on this matter. Commissioner Goodman, therefore, expects that any agreement will be reached by adopting a document as a whole or by using the procedures of Roberts' Rules to propose amendments to a document as a whole. He said he will not call for a vote today but will summarize his most recent proposal (see Agenda Document No. 16-13-A-1) which is based on Commissioner Weintraub's proposal. He then reviewed the distinctions between their two proposals and said he would be happy to continue to work on this with his colleagues between now and the next meeting.

Chairman Petersen recognized Commissioner Weintraub who thanked Commissioner Goodman for the feedback. She believes that there are large areas of agreement in the document and is hopeful that, by the next meeting, they can agree on those portions that both sides are comfortable with and continue to work on those portions that are more controversial.

final rule to be effective no later than August 1, 2016 and to make annual

adjustments thereafter. The Act also sets out new formulas for making inflation

adjustments. Discussion followed.
