SUBJECT: Status of Enforcement --- Fiscal Year 2018, First Quarter (10/1/2017 -12/31/17)

To assist the Commission and the Office of General Counsel in assessing the current productivity of the Commission's enforcement program, we submit the Status of Enforcement for the First Quarter of Fiscal Year 2018 (10/1/2017 - 12/31/17). The tables that follow provide information to assist agency management in its review of the enforcement program. This report includes the new information required by the amendment to Directive 68 that was approved by the Commission on December 14, 2017, with the exception of the information regarding holdover requests (items II.B.2.i and j) which we are still compiling. We will forward the holdover information to the Commission as an addendum to this report as soon as it is complete.

In summary, at the close of the quarter the total caseload was 241 — 192 active and 49 inactive. During the quarter, Complaints Examination & Legal Administration ("CELA") circulated 9 EPS reports in an average of 72 days. The Enforcement Division circulated First General Counsel's Reports in 23 matters in an average of 164 days, meeting the internal circulation goal 65% of the time. The Commission completed pre-probable cause conciliation with 6 respondents in an average of 93 days. There were 21 matters pending in the investigation stage at the close of the quarter. The Commission closed 38 matters in an average of 453 days from the receipt of the complaint or referral, with 31 of those matters (82%) closing within 15 months of receipt. The Commission negotiated a total of \$400,700 in civil penalties for all matters that closed during the quarter.
