ELECTION ADMINISTRATION ADVISORY PANEL MEETING AUGUST 23 - 24

WASHINGTON -- The Federal Election Commission Election Administration Advisory Panel will meet August 23-24 at the ANA Hotel in Washington, D.C.

The Election Administration Advisory Panel for 1996 is composed of 20 state election officials and two associate members, the latter from Canada and Mexico. The panel works closely with the Federal Election Commission's Clearinghouse on Election Administration.

Proposed agenda for this year's panel meeting includes: use of the Internet by election officials; progress in computerizing statewide election systems; NVRA ("Motor Voter") reporting requirements; changes in federal election law; commercializing voter registration; the future of polling place accessibility; downsizing election operations.

The panel will present its views on problems in the administration of federal elections, and formulate recommendations to the Clearinghouse for future program development.

The meeting is open to the public. Hours for the Advisory Panel sessions are 8:30 a.m. to 5 p.m. on August 23 and 9 a.m. to 2:30 p.m. on August 24. The ANA Hotel is at 2401 M Street, NW, in Washington.
