**ARTICLES OF INCORPORATION  
OF  
AMERICAN PATRIOT FOUNDATION**

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a corporation which shall have its principal office in the District of Columbia, and which is organized under the NON-PROFIT CORPORATION ACT (D.C. Code, Title 29, Chapter 3) of the District of Columbia, do hereby adopt the following Articles of Incorporation:

**FIRST:** The name of the corporation is AMERICAN PATRIOT FOUNDATION.

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purpose or purposes for which this corporation is organized, are: To be a non-partisan, non-profit national foundation with the primary function of educating the American public as to the importance and relevance in today's society of the United States Constitution, the Declaration of Independence, the Federalist Papers and other founding documents. To achieve this goal, the corporation will educate and advocate (through a broad diversity of educational programs) to the American public the importance in today's society of patriotism itself, and of the patriotism of the founding fathers and other patriots throughout our nation's history, and how their philosophies shape our destiny, and thereby to rediscover our heritage of freedom.

**FOURTH:** The corporation will not have members.

**FIFTH:** The Board of Directors of the corporation shall by majority vote, elect successor and additional directors.

**SIXTH:** The internal affairs of the Corporation shall be managed by persons hired by the Board of Directors for that purpose, specifically, the President, the Executive Director, the General Counsel/Secretary, and the Treasurer. A person can hold more than one of these titles simultaneously except for the President or Vice President cannot act as the Secretary or the Assistant Secretary. Management shall have the responsibility for the daily operations of the corporation to achieve the above-stated purposes of the corporation. Such managerial responsibilities shall include but not be limited to programming, conducting fundraising, establishing and maintaining internal accounting controls and managing information technology.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from federal income tax under section 501 ( c ) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 ( c ) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**SEVENTH:** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 ( c ) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the District of Columbia if the principal office of the corporation is then located in the District of Columbia (if the principal office of the corporation is not then located in the District of Columbia, then by a Court of Competent Jurisdiction in the State and County in which the principal office of the corporation is then located) exclusively for such purposes or to such organization or such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**EIGHTH:** The address of the initial registered office of the corporation is: 401 D Street, NE, Washington, D.C. 20002. The name and address of the initial registered agent at such address is: Sue Corrigan.

**NINTH:** The number of directors constituting the Board of Directors is three, provided however, that the Board of Directors may from time to time by majority vote, increase or decrease its number without formal amendment of these Articles of Incorporation, provided however, there shall never be less than three directors. 
