
Dear Mr. Jordan:

This letter responds to the complaint filed with the Commission by Lenora B. Fulani and the Committee for a Unified Independent Party on November 7, 2003, which was received by CNN on November 24, 2003. Enclosed herewith is a signed Statement of Designation of Counsel. CNN appreciates the opportunity to respond and does so as follows.

The Complainant alleges that CNN has and/or will violate the prohibition against corporate contributions because of a debate it sponsored on October 9, 2003, in Phoenix, AZ, and, according to Complainant, because CNN will more than likely sponsor other debates in the future. Complainant correctly points out that it requested CNN's criteria for its debates and that CNN provided its criteria as requested (Complainant's Exhibit B).

At the time of the October 9 debate in Arizona, Ms. Fulani was not registered with the Commission as a candidate for the 2004 presidential election. To the best of CNN's knowledge, at the time of the debate, Ms. Fulani had neither raised a significant amount of money nor was she factoring high enough in public opinion polls. Based on these conclusions, CNN did not extend Ms. Fulani an invitation to participate in the October 9 debate. As for any future debates, CNN cannot identify at this time who will be invited to participate, however, it will base its decision on its pre-established criteria.
