Dear Mr. Peterson:

Thank you for sending me copy of the Commission's RTB Notification Letter in MURs 17 and 29, together with the underlying Factual and Legal Analysis. I will represent Our American Revival in these matters. A Designation of Counsel form signed by OAR's new Treasurer, Ryan Burchfield, accompanies this letter.

The Commission mailed the RTB letter and FLA to n address that OAR no longer m int ins, and I understand that the Postal Service returned the Commission's letter as undeliverable. Accordingly, OAR did not receive the letter until you sent it to me yesterday, after the deadline for responding to it had passed. Moreover, these matters now re over four years old. We last engaged on these matters on June 1, 2015, when it responded to the underlying complaints.

OAR absolutely wishes to respond to the Commission's findings by submitting additional inform tion for the Commission to consider. Under the circumstances—specifically, the delay of nearly four years since our last engagement on this matter, the f ct th t the Commission h s resolved several other potentially relevant matters in that time, the mailing of the RTB letter and FLA to n address that in the interim has been closed, the turnover of OAR's personnel, and the complexity and significance of the legal issues t stake—we request the maximum opportunity to respond available as part of the Commission's process. For these reasons, we seek an extension until June , 2019, which is fifteen days from the date we received your letter.
