We write regarding MUR 7147, for which a response is currently due on January 15. We respectfully request an extension until February 15, 2017 to file our response. The 57 page complaint raises a host of issues regarding the PAC, several vendors and several private citizens, with claims reaching far and wide. Most of the individuals with knowledge of the matters at issue are working 7 days a week on the transition team, with several of them having already being named as senior members of the President-elect's staff. As such, we have not been able to gather the necessary information, documentary and testimonial to be able to properly present a full and complete response to the Commission.
