
I, Darin Knepper, complainant, aver the following:

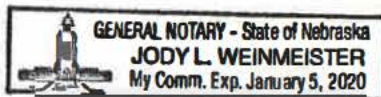
Facebook has been inserting counterposts following posts which contain negative information about Democrat political candidates in my Facebook account feeds (I have multiple accounts/feeds due to being suspended at times). These counterposts dispute the posts of my Facebook "friends," and the friends' posts I refer to are critical of, for example, congressmen or women, often when they have active political campaigns. This constitutes unreported, in-kind campaign contributions by the Facebook corporation. I have included a couple of examples dating from this summer (2019) relating to Ilhan Omar and "Beto" O'Rourke in my enclosed documents. The screen-captures show more than I was able to get to print, and they are available in full form if I can email them. One will notice that the counterposts directly follow posts Facebook has obviously identified as target posts that "need correcting." Friends (Facebook "friends") or friends of friends have confirmed to me that these counterposts appear in their feeds as well, following the same posts. Whether the posts or counterposts are "accurate" is irrelevant, as the attempt to assist a political candidate in his or her campaign is the issue. It is my belief that this practice must be widespread enough for me to notice it, and discoverable and confirmable through cursory investigation.

Filing a complaint and early stages of complaint process

Filing the complaint

By law, all complaints must be made in writing and must provide the full name and address of the person filing the complaint (the "complainant"). They must be signed, sworn to, and notarized, meaning that the notary's certificate must state that the complaint was "signed and sworn to before me" or must indicate that the complainant affirmed the complaint "under penalty of perjury." Complaints must be sent to the FEC at:
