  - a. Find no reason to believe that Illeana Ros-Lehtinen, IRL PAC and Ed Torgas in his official capacity as treasurer (terminated), and South Florida First PAC (f/k/a Ros- Lehtinen for Congress) and Antonio Argiz in his official capacity as treasurer (terminated) violated 52 U.S.C. § 30114(b).

  - c. Close the file.

2. Failed by a vote of 3-3 to:

- b. Find reason to believe that IRL PAC and Ed Torgas in his official capacity as treasurer (terminated) violated 52 U.S.C. § 30114(b).
- c. Find reason to believe that South Florida First PAC (f/k/a Ros-Lehtinen for Congress) and Antonio Argiz in his official capacity as treasurer (terminated) violated 52 U.S.C. § 30114(b).
- d. Approve the Factual and Legal Analysis, as recommended in the First General Counsel's Report dated May 22, 2020.
- e. Authorize the use of compulsory process.
- f. Approve the appropriate letter.

Commissioners Broussard, Walther, and Weintraub voted affirmatively for the motion.

Commissioners Cooksey, Dickerson, and Trainor dissented,

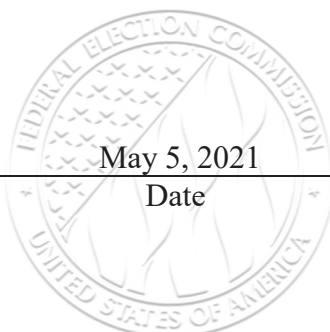
3. Failed by a vote of 3-2 to:
