Tina Ramirez is a Republican primary candidate running for the Republican nomination for Virginia's $7^{\text {th }}$ US Congressional District. After combing over Tina Ramirez's recent Q4 filing, I created an excel spreadsheet tracking her campaign's receipts and expenditures for the last quarter of 2019 (included with this letter).

As you will see, the Ramirez campaign went into the red with primary election funds on $11 / 1 / 19$ and never went back. In short, from November $1^{\text {st }}$ to the end of the 2019-year, Ramirez was tapping into general election funds to pay for her primary campaign.

Please look into this matter, as I feel it should be brought to the attention of the FEC. I appreciate your attention to this issue.
