**I. INTRODUCTION**

The Complaint alleges that Undivided Purpose, an independent expenditure-only political committee (“IEOPC”), may have coordinated an advertisement with the authorized committee of Teresa Tomlinson, a candidate for United States Senate from Georgia in 2020, in violation of the Federal Election Campaign Act of 1971, as amended (the “Act”). Teresa Tomlinson for Senate and Sheri Labovitz in her official capacity as treasurer (“Tomlinson Committee”) and Undivided Purpose deny any coordination and request that the Commission find no reason to believe that they violated the Act. For the reasons set forth below, we recommend that the Commission

1 dismiss the allegation that Undivided Purpose made, and the Tomlinson Committee accepted, an  
2 excessive in-kind contribution in the form of a coordinated communication, and close the file.

## 3 **II. FACTUAL AND LEGAL ANALYSIS**

### 4 **A. Factual Summary**

5 Tomlinson was a candidate in the June 9, 2020 Democratic primary election for U.S.  
6 Senate in Georgia.<sup>1</sup> Undivided Purpose is an IEOPC that was established in 2020 and made a  
7 total of \$106,812.50 in independent expenditures for television advertising in support of  
8 Tomlinson.<sup>2</sup>

9 The Complaint states that Undivided Purpose made an independent expenditure of  
10 \$10,000 on May 13, 2020 to Mad River Communications (“Mad River”), a digital advertising  
11 firm, for an advertisement in support of Tomlinson.<sup>3</sup> The Complaint alleges that Mad River  
12 shares an address and a principal with another vendor, Trippi, Norton and Rossmeyssl Campaigns  
13 (“TNR”), a political consulting firm which was hired by the Tomlinson Committee.<sup>4</sup> The

1 Complaint also alleges that Undivided Purpose uses the same fundraising firm, Berger  
2 Hirschberg Strategies (“BHS”), that the Tomlinson Committee employs.<sup>5</sup> Because of “the  
3 similarities in consulting firms and principals” between the Tomlinson Committee and  
4 Undivided Purpose, the Complaint requests that the Commission “conduct an immediate and  
5 comprehensive review to ensure no coordination has taken place” between the Tomlinson  
6 Committee and Undivided Purpose.<sup>6</sup>

7 In response, the Tomlinson Committee asserts that the Complaint does not provide any  
8 instance or documentation of direct contacts between it and Undivided Purpose or information  
9 about its plans, projects or activities that were improperly shared by TNR.<sup>7</sup> The Tomlinson  
10 Committee acknowledges that TNR and BHS were a political consultant and fundraising vendor,  
11 respectively, to the Committee, but it had no arrangement with Mad River.<sup>8</sup> The Tomlinson  
12 Committee and Undivided Purpose both assert that their vendors employed firewalls for their  
13 staff working on matters relating to the Tomlinson Committee that separated them from their  
14 staff working on projects for independent expenditure committees to make sure that no material  
15 information was shared.<sup>9</sup>

1 Respondents provided copies of the firewall policies established by both TNR and  
2 BHS.<sup>10</sup> TNR's firewall policy is dated March 30, 2020, which is more than a month before  
3 Undivided Purpose made expenditures to Mad River for digital advertising and television  
4 advertising production on behalf of the Tomlinson Committee. TNR's firewall policy also  
5 designated specific employees to work on either the independent expenditure team or the  
6 candidate team with respect to various campaigns including the U.S. Senate election in  
7 Georgia.<sup>11</sup>

8 Further, the Tomlinson Committee submitted a sworn declaration by Julia Norton, a  
9 partner at TNR, stating that she was the lead person at TNR working with the Tomlinson  
10 Committee.<sup>12</sup> Additionally, Norton's sworn declaration states that TNR maintained a firewall  
11 policy and no material information about the Tomlinson Committee was shared with staff  
12 working on independent expenditures in this specific election race, and that staff working on  
13 independent expenditure activities in this specific election did so out of Mad River.<sup>13</sup> Further,  
14 Norton's sworn declaration also states that TNR is "associated with" Mad River, but Mad River  
15 is a "distinct" company.<sup>14</sup>

16 With respect to its commercial relationship with BHS, the Tomlinson Committee states  
17 that while BHS is not subject to the Commission's common vendor regulations because it is a  
18 fundraising firm and not involved in producing public communications, it still maintained a

1 firewall between BHS staff working on fundraising for the Tomlinson Committee and staff  
2 conducting fundraising for Undivided Purpose.<sup>15</sup> The Tomlinson Committee also submitted a  
3 sworn declaration by Stephanie Berger of BHS that no material information about the plans and  
4 activities of the Tomlinson Committee was shared with BHS staff working on matters for  
5 Undivided Purpose.<sup>16</sup>

6 Finally, the Tomlinson Committee claims that the Complaint cannot presume  
7 coordination based solely on the fact that it and Undivided Purpose have common vendors.<sup>17</sup>  
8 The Tomlinson Committee and Undivided Purpose assert that the Commission should find no  
9 reason to believe that they violated the Act.<sup>18</sup>

## 10 **B. Legal Analysis**

11 The Act provides that an expenditure made by any person in “cooperation, consultation,  
12 or concert with, or at the request or suggestion of, a candidate, his or her authorized political  
13 committees, or their agents,” constitutes an in-kind contribution.<sup>19</sup> IEOPCs are prohibited from  
14 making contributions to candidates and their authorized committees.<sup>20</sup> It is unlawful for

1 candidates, political committees, and their officers and employees to knowingly accept an  
2 excessive contribution.<sup>21</sup>

3 The Commission's regulations provide a three-part test for determining when a  
4 communication is a coordinated expenditure, which is treated as an in-kind contribution.<sup>22</sup>

5 A communication is coordinated if it: (1) is paid for by a third party; (2) satisfies one of five  
6 content standards set forth at 11 C.F.R. § 109.21(c);<sup>23</sup> and (3) satisfies one of six conduct  
7 standards set forth at 11 C.F.R. § 109.21(d).<sup>24</sup> All three prongs must be satisfied for a  
8 communication to be coordinated under the regulations.<sup>25</sup>

9 Applying the coordinated communication test, the payment prong is satisfied because  
10 Undivided Purpose, a third party, paid for the communication in support of Teresa Tomlinson  
11 cited in the complaint in the amount of \$10,000.<sup>26</sup> Given that it was reported as an independent  
12 expenditure, as were other payments by Undivided Purpose for communications, such

1 communications presumably also satisfy the content prong as public communications that  
2 expressly advocate the election or defeat of a clearly identified candidate for federal office.<sup>27</sup>

3       As to the conduct prong of the coordinated communication test, the Complaint did not  
4 provide any information that would satisfy any of the conduct standards set forth in 11 C.F.R.  
5 § 109.21(d). The Complaint alleges overlap between the Tomlinson Committee and Undivided  
6 Purpose vendors, thus raising the “common vendor” conduct standard. The conduct prong may  
7 be satisfied if the parties contracted with or employed a common vendor that used or conveyed  
8 material information about the campaign’s plans, projects or activities or needs, or used material  
9 information gained from past work with the candidate to create, produce, or distribute the  
10 communication.<sup>28</sup>

11       The MUR record contains no evidence indicating that information about Teresa  
12 Tomlinson’s plans, projects or activities material to the creation, production, or distribution of  
13 the communications was used by or conveyed to the vendors. While it is not clear whether Mad  
14 River and TNR, as “associated” entities, comprise common vendors for purposes of the  
15 coordinated communication analysis, the record does not contain any information that the  
16 Tomlinson Committee communicated with Mad River. Further, the sworn declaration from Julia  
17 Norton of TNR states that no information about the Tomlinson Committee’s communications  
18 plans were conveyed to anyone working on independent expenditures in connection with this  
19 Senate election, and she provided TNR’s firewall policy.<sup>29</sup> The other vendor, BHS, is a

1 fundraising firm that is not involved in creating and disseminating public communications for  
 2 candidates or independent expenditure committees, but it also provided an affidavit explaining  
 3 its firewall policy and provided the policy itself.<sup>30</sup> The mere fact that the Tomlinson Committee  
 4 and Undivided Purpose may employ common vendors is insufficient, by itself, to determine  
 5 coordination.<sup>31</sup> Nor do any of the other conduct standards appear to be met.<sup>32</sup>

6 In the absence of any available information supporting the coordination allegation, we  
 7 recommend that the Commission dismiss the allegation that Undivided Purpose made, and the  
 8 Tomlinson Committee accepted, an excessive in-kind contribution.

#### 9 **IV. RECOMMENDATIONS**

- 10 1. Dismiss the allegation that Teresa Tomlinson for Senate and Sheri Lavobitz in her  
 11 official capacity as treasurer violated 52 U.S.C. § 30116(f);
- 12
- 13 2. Dismiss the allegation that Undivided Purpose and Victoria Perrone in her official  
 14 capacity as treasurer violated 52 U.S.C. § 30116(a);
