To whom it may concern:

Rep. Matt Gaetz' congressional campaign (Respondent: "Matt Gaetz for Congress") authorized the purchase of a radio ad on 7/15/2020. The WNRP order for the radio ad referenced lists the client as "Matt Gaetz for Congress" which would make "Matt Gaetz for Congress" the "authorized committee of the legally qualified candidate." However, the actual radio commercial says it was paid for by "Friends of Matt Gaetz," not "Matt Gaetz for Congress." This would make the referenced purchase from WNRP an undisclosed purchase from his congressional campaign account. Since the radio ad in question does not state "Paid for by Matt Gaetz for Congress" but instead "Paid by Friends of Matt Gaetz," this radio ad from the WNRP order contains an improper disclaimer. All of the other purchase orders for other radio stations list the client for this particular radio ad as "Friends of Matt Gaetz" and can be found at https://publicfiles.fcc.gov/.

The WNRP purchase order in question, as well as the radio ad, are also attached.

Please see references of specific provisions in which these violations occur below.

Disclaimers for authorized committees

If the candidate or candidate's campaign authorizes and finances a communication (including any solicitation) requiring a disclaimer, the notice must state that the communication was paid for by the authorized committee. Additional requirements apply for print, television and radio ads, as explained on this page in the sections specific to those types of advertisements.

Authorized by candidate's committee

In addition to the requirements already noted, radio and television communications (or any broadcast, cable or satellite transmission) that are authorized or paid for by a campaign require additional language. For such ads, the candidate must deliver an audio statement identifying themself and stating that the candidate has approved of the communication. For example, "I am [candidate's name], a candidate for [federal office sought], and I approved this advertisement."

Dear Mr. Dosev:

This is in response to your email to the Federal Election Commission (the "Commission"), received on August 10, 2020. The Federal Election Campaign Act of 1971, as amended (the "Act") and Commission Regulations require that the contents of a complaint meet certain specific requirements. Your email and its attachment do not meet these requirements. Specifically, although your correspondence was notarized and signed in the presence of a notary public, it was not sworn to, as required under the Act.

In order to file a legally sufficient complaint, you must swear before a notary that the contents of your complaint are true to the best of your knowledge and the notary must represent as part of the jurat that such swearing occurred. See 52 U.S.C. § 30109(a)(1). The preferred form is "Subscribed and sworn to before me on this ______ day of ______, 2020." Note, it is not sufficient for the notary to acknowledge the identity of the individual before him or her. We regret the inconvenience that these requirements may cause you, but we are not statutorily empowered to proceed with the handling of a compliance action unless all the statutory requirements are fulfilled. See 52 U.S.C. § 30109.

Please note that this matter will remain confidential for a 15 day period to allow you to correct the defects in your complaint. Any corrections to your complaint must be submitted in writing to the General Counsel at the FEC's street address, or submitted by email to EnfComplaint@fec.gov, if you are in a state in which electronic notarization is permissible.

As indicated on the Commission's website at https://www.fec.gov/resources/cms-content/documents/status_of_fec_operations_8-10-2020.pdf, the Commission has resumed processing mail delivered via USPS, UPS, DHL, and FedEx (collectively, "mail"). The agency will not accept or process any documents or correspondence delivered by courier. Incoming mail, including enforcement complaints, will typically be processed on a weekly basis. Therefore, to avoid potential mail processing delays, the Commission requests that, if you file a complaint by mail, you also send an electronic copy of the complaint to EnfComplaint@fec.gov.

The Commission encourages the use of electronic signatures on, and electronic notarizations of, such electronically submitted complaints from states in which electronic notarization is available. Your state appears to provide an option for using an electronic notary, if you are unable to obtain a physical notary signature. Electronically submitted copies of corrected complaints that otherwise appear to be in order will be deemed received on the date the copy was electronically received by staff. Corrected complaints that are filed only by mail will be deemed received when actually received by Office of General Counsel staff, subject to mail processing delays.

If the complaint is corrected and refiled within the 15 day period, the respondents will be so informed and provided a copy of the corrected complaint. If the complaint is not corrected, the file will be closed and no additional notification will be provided to the respondents.
