## COMPLAINT


This complaint is filed under 52 U.S.C. § 30109(a)(1) against Senator Cory Gardner, Cory Gardner for Senate, and Lisa Lisker in her official capacity as treasurer of Cory Gardner for Senate (collectively, "Respondents") for violating the Federal Election Campaign Act of 1971, as amended (the "Act"), and Federal Election Commission (the "Commission" or "FEC") regulations. Respondents violated federal law and regulations when they authorized and made disbursements for the purpose of financing two different television advertisements that failed to comply with the FEC's disclaimer requirements. These requirements are straightforward and easy to follow for even first-time candidates, much less Senator Gardner who first ran for U.S. Senate six years ago. Breaking the FEC's disclaimer requirements may be a technical violation, but it is a serious one. The disclaimer requirements exist to ensure that Americans are always clearly and conspicuously informed of who paid for and authorized the electoral advertisements that attempt to influence their vote. Consequently, the Commission should immediately

investigate this pattern of repeated violations and take appropriate remedial action against Respondents.

## **FACTS**

Cory Gardner is a current U.S. Senator from the State of Colorado. Senator Gardner is a candidate for re-election in 2020. Cory Gardner for Senate is Senator Gardner's principal campaign committee and Lisa Lisker is its treasurer.

Cory Gardner for Senate paid for, and Senator Cory Gardner authorized, a thirty (30) second television advertisement, entitled "Major Victories," that began airing on Tuesday, June 2, 2020.<sup>3</sup> The advertisement included a verbal statement by Senator Gardner approving the communication ("I'm Cory Gardner and I approve this message").<sup>4</sup> However, the image of Senator Gardner that accompanied this statement clearly occupied less than 80 percent of the vertical screen height, as shown below.<sup>5</sup>



On August 13, 2020, Respondents began airing another thirty (30) second television commercial, entitled "Both Parties," with the same flaw.<sup>6</sup> As Senator Gardner speaks the words, "I'm Cory Gardner and I approve this message," his image on the screen takes up only a small percentage of the vertical screen height.<sup>7</sup> As shown below, his image is much less than 80 percent of the screen.<sup>8</sup>



**LEGAL DISCUSSION** 

Under the Act, a political committee must include a "paid for by" disclaimer on all public communications that it finances.<sup>9</sup> Perhaps recognizing the outsized impact that television advertisements have in our elections, the Act and FEC regulations impose additional disclaimer requirements on television advertisements beyond the standard "paid for by" disclaimer. Any television advertisement paid for and authorized by a candidate and/or an authorized committee of the candidate must include specific disclaimers.<sup>10</sup> First, during the television advertisement,

the candidate must make a statement (1) identifying him or herself and (2) stating that he or she approves of the advertisement.<sup>11</sup> The candidate may make this statement in two ways: (1) "[t]hrough an unobscured, full-screen view of himself or herself making the statement;" or (2) "[t]hrough a voice-over by himself or herself, accompanied by a clearly identifiable photographic or similar image of the candidate." The candidate is "clearly identifiable" only if the photograph or similar image is "at least eighty (80) percent of the vertical screen height." 13 Additionally, there must be a similar written disclaimer at the end of a television advertisement

Here, Respondents' television advertisements do not comply with the Act and Commission's regulations because there is no "clearly identifiable" image of Senator Gardner during the Senator's voiced-over "stand-by-your-ad" statements. Neither image of Senator Gardner that appears on the screen during the two ads is 80 percent of the vertical screen height. Rather, one of the images is a video clip of Senator Gardner, which is playing within a small box on the screen, and Senator Gardner does not even take up the whole height of that box. The other advertisement has a video of Senator Gardner walking in the woods, in which Senator Gardner plainly takes up less than 50 percent of the screen and is shown from a distance that makes him even more difficult to identify. Therefore, Respondents have violated federal law at 52 U.S.C. § 30120(d)(1)(B)(i)(II) and the Commission's regulations at 11 C.F.R. § 110.11(c)(3)(ii)(B) by failing to include a clearly identifiable image of Senator Gardner in multiple of its television ads.

There is no valid excuse or justification for Respondents' failure to comply with these disclaimer requirements. As an incumbent Member of the Senate, Senator Gardner has previously run for office and has experience producing, paying for, and authorizing political advertisements. Moreover, as an incumbent candidate, he is well-aware of the importance of disclaimers and the legal requirements that make them effective. Yet, Senator Gardner has repeatedly chosen to ignore these rules and run ads that make it difficult for the public to discern his identity from the screen. Respondents' repeated violations of the law undermine the very purpose of disclaimers: to ensure that all Americans know who pays for and sponsors political advertisements.

## REQUESTED ACTION

As we have shown, Respondents appear to have violated the Act and Commission's regulations by twice failing to include a clearly identifiable image of Senator Gardner during the "stand-by-your-ad" disclaimer in Respondents' television advertisements. As such, we respectfully request that the Commission immediately investigate these violations and that Respondents be enjoined from further violations and be fined the maximum amount permitted by law.
