Dear Mr. Burns:

On October 29, 2020, the Federal Election Commission notified your client, Montcalm LLC, of a complaint alleging violations of certain sections of the Federal Election Campaign Act of 1971, as amended (the "Act").

On February 27, 2024, the Commission found, on the basis of the information in the complaint and your response, that there is no reason to believe Montcalm LLC violated 52 U.S.C. §§ 30102, 30103, or 30104 by failing to register and report as a political committee. There was an insufficient number of votes to find reason to believe Montcalm LLC violated 52 U.S.C. § 30122 by knowingly permitting its name to be used to effect a contribution in the name of another. Accordingly, the Commission closed its file in this matter.

Documents related to the case will be placed on the public record within 30 days. *See* Disclosure of Certain Documents in Enforcement and Other Matters, 81 Fed. Reg. 50,702 (Aug. 2, 2016). A Statement of Reasons and, if applicable, a Factual and Legal Analysis further explaining the Commission's decision will follow.
