The undersigned serves as counsel to Fair Fight and Treasurer, Camille Johnson. This letter responds to the Commission's notification that it received a complaint (the "Complaint") alleging that Fair Fight violated the Federal Election Campaign Act (the "Act") and Federal Election Commission (the "Commission") regulations by accepting a contribution from a foreign national.

The complaint alleges that Oonagh McQuarrie, an Arizona resident, made an illegal contribution to Fair Fight based on the complainant's belief that Ms. McQuarrie is ineligible to contribute to Fair Fight. However, Ms. McQuarrie is a Permanent Resident and her permanent resident card is attached as Exhibit A.¹

As a Permanent Resident, Ms. McQuarrie is eligible to contribute to Fair Fight. As such, the Commission should find no reason to believe that Fair Fight violated the Act and dismiss the Complaint.


