Turner brings this complaint before the Federal Election Commission seeking an investigation and enforcement action against Dream Big Nevada, Astrid Silva, the Democratic National Committee, Hillary R Clinton, and Catherine Cortez Masto, for direct and serious violations of the Federal Election Campaign Act. This complaint is filed pursuant to 52 U.S.C. 30109(a)(1) and is based on information providing reason to believe that:


- 1 Astrid Silva: founder, executive director and C.E.O. of Dream Big Nevada is a foreign national illegal alien and has used Dream Big Nevada to Campaign for, fund and influence Democratic Party Presidential candidates during the 2020 Democratic Presidential primary campaign season. She has provided "a thing of value" to Kamala Harris, Elizabeth Warren, Joe Biden, Cory Booker, Julian Castro, and Pete Buttigieg; who meet with her while campaigning prior to the 2019 Las Vegas, Nevada debate and the 2020 Nevada caucus.
- 2 Dream Big Nevada a registered 501(c)(3) EIN 82-2765806; 2900 Stewart Ave, Las Vegas, NV 89119. Participated in the 2020 Nevada Democratic Presidential Caucuses. As this registered charity is founded, and headed by a foreign national illegal alien their is undue influence over its electioneering activities.
- 3 The Democratic National Committee has been provided with "something of value" by Astrid Silva and Dream Big Nevada. She spoke at the 2016 DNC and provided official Democratic party political commentary to the 2017 State of the Union speech.
- 4 Hillary R Clinton 2016 Presidential campaign: Astrid Silva appeared in campaign ads; FL, IA, NV, NC, OH and PA ~10 Oct, 2016.
- 5 Catherine Cortez Masto 2016 Nevada Federal Senate campaign was provided "a thing of value" by Astrid Silva.
