This Complaint is filed against American Muckrakers PAC, Inc., FEC ID C00776062 for substantial and numerous violations of the federal election campaign laws and Federal Election Commission regulations. The violations are summarized below and evidence substantiating each violation is attached.

I. Introduction

American Muckrakers PAC, Inc. (“PAC”) has violated federal campaign laws and regulations by failing to properly report independent expenditures and failing to include required disclaimers on PAC advertising and solicitation materials. These violations occurred as part of the PAC’s aggressive engagement on federal candidate elections through its website, press releases, and social media posts. Most recently, the PAC expressly advocated for the defeat of Lauren Boebert in Colorado’s Third Congressional District immediately before the primary election, where the PAC manufactured and broadcast patently false and defamatory statements without the required reporting or disclaimers. As detailed below, these violations include failure to report independent expenditures in violation of 11 CFR § 104.4, failure to include required independent expenditure disclaimers in violation of 11 CFR § 110.11, and failure to include required solicitation disclaimers in violation of 11 CFR § 102.5.

II. Violations

A. Independent Expenditures

The PAC has created and maintains the website <https://www.fireboebert.com/>. On this website, the PAC expressly advocated the defeat of Rep. Boebert in the June 28, 2022, primary election. The website contained the explicit words “fire Lauren Boebert” to advocate her defeat and is subject to the only reasonable interpretation that it advocated a vote against Rep. Boebert in the primary election. See **Exhibit A**.

The PAC created a video and other communications that it distributed to voters via the website and social media posts in the weeks prior to the primary election that expressly advocated against Rep. Boebert, explicitly supporting Rep. Boebert's primary opponent by stating "Vote for Colorado Senator Don Coram for Congress" and also urging "No. Second. Term. For. Lauren. Boebert." "@AdamForColorado can win and we like him a lot! Please follow him and support him." See **Exhibit B**. There is a substantial amount of time and expense involved in the PAC's efforts to create and distribute communications that all include the explicit words "fire Lauren Boebert." See **Exhibit C** (including social media posts over about one month, from June 20 through the end of July).

The PAC did not disclose independent expenditures on its FEC Reports of Receipts and Disbursements for this website, content development, or social media distribution as independent expenditures made against Rep. Boebert. In addition, the PAC's website and social media communications omitted the required disclaimer stating that the communication was not authorized by any candidate.

B. Fundraising Solicitations

The PAC solicits contributions on its website via direct donation and donations in exchange for a t-shirt. See **Exhibit D**. The PAC fails to state the disclaimer that the communication was not authorized by any candidate and fails to inform donors that their contributions will be used in connection with a federal election or that they are subject to the limitations and prohibitions of the Federal Election Campaign Act.

Furthermore, we have submitted notice to the Internal Revenue Service that the PAC violated Section 6113 of the Internal Revenue Code requiring political committees to include a special notice on solicitations informing solicitees that their contributions are not tax deductible.

C. Text Communications

The PAC's recent reports include disclosure of expenditures for "text messaging services." See American Muckrakers PAC Pre-Primary report, FEC-1602933, filed 06/16/2022. While I am not in receipt of any texts sent on behalf of the PAC, it is likely that the messages expressly advocated against Rep. Boebert given the other activities and the PAC's mission of having its "sights are set on Lauren Bobert" [sic]. **Exhibit E**. The FEC can obtain these text message communications to determine whether these PAC-funded text messages expressly advocated against Rep. Boebert and if the PAC failed to report these independent expenditures.

III. Conclusion

Muckrakers registered with the FEC as an independent expenditure committee and engaged in express advocacy and electioneering communications without filing required disclosures and including required disclaimers. This letter details specific violations under the FEC's jurisdiction and requests that the FEC investigate the full scope of violations.

Muckrakers is not an inexperienced organization that inadvertently failed to comply with legal requirements. This is a well-funded and sophisticated political organization. FEC reports show the organization retained campaign counsel and has engaged in multiple federal elections. Muckrakers pays high retainer amounts to its professional political consultant/PAC President and Treasurer, David Wheeler. Despite all of this, Muckrakers chose not to comply with basic federal campaign finance rules. Muckrakers continues to engage in improper conduct through its ongoing activities.

Muckrakers routinely makes false claims against federal candidates and their families to serve its partisan political objectives. It is critical that the public have access to who is responsible for this activity through legally required disclaimers and reporting. Muckrakers chose not to report or disclose its political activity as required by law and it is imperative that the FEC complete an enforcement action to address Muckrakers substantial legal violations.

Thank you for your prompt attention to this ongoing FEC non-compliance matter.



June 14, 2022 - SILT, COLORADO: The American Muckrakers PAC, Inc., today announced their team and volunteers have uncovered that Lauren BoeBERT was an unlicensed, paid escort and met clients through SugarDaddyMeet.com. Text messages show she was bankrupt at the time and looking for "side income" and called her work "pay to play". She was paid to "escort" wealthy men.

According to our investigation, BoeBERT was hired by a wealthy male client in Aspen, Colorado, who was a Koch family member. BoeBERT's rich client subsequently introduced her to U.S. Senator Ted Cruz (R-TX) in Aspen. After meeting with Senator Cruz, BoeBERT was encouraged by Cruz to run for political office. When BoeBERT announced her campaign for Congress in December 2019, Senator Cruz donated at least \$136,250.00 to the BoeBERT Campaign and helped her raise large sums of money during trips BoeBERT made to Texas. BoeBERT didn't disclose a \$70,500.00 donation made by Cruz until Cruz's Federal Election Commission filings contradicted her own filings.

BoeBERT had an abortion at a clinic in Grand Junction, Colorado, sometime in 2004 or 2005 when she was approximately eighteen years old. It is not known whether this abortion was related to SugarDaddyMeet.com clients or someone else. Then, BoeBERT, twenty-three at the time, had an abortion in 2009 at the Planned Parenthood Clinic in Glenwood Springs, Colorado, "due to her work with a SugarDaddyMeet.com client".

American Muckrakers obtained this information through an exhaustive investigation and a tip from a verified source close to this matter who has requested anonymity for fear of reprisals.
