



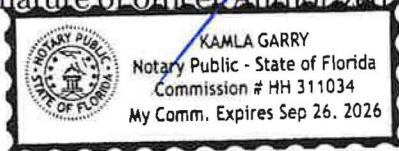

The following are a list of 5 Complaints against Cory L Mills, Congressman elect of Congressional District 7 of Florida. Attached to the Complaints are Exhibits that support the allegations. In this filing there are a total of 5 Complaints and supporting documentation. These complaints are based on

findings in FEC Form 3 filings for Cory Mills and Laura Loomer. These complaints are also based on a Financial Disclosure Report to Congress that does not match the FEC filings pertaining to Campaign Contributions. These documents are submitted as Exhibits. Additional Exhibits are provided to support the findings.

## Complaint 1

1. Cory Mills made several statements on his Financial Disclosure Report filing that are apparently false. The Report leads to questions about his sources of funds, loans and liabilities on FEC Form 3 submittals. See his House Financial Disclosure Report on 5/7/2021 **Exhibit 1**.
2. Mills filed his House Financial Disclosure Report on 5/7/2021 for the year 2021. Note he has since failed to file a report that was due in May 2022.
3. On his Financial Disclosure Report he filed on 5/7/2021 for the year 2021 he reported six lines of assets in Schedule A.

- a. In Schedule A Mills reports his home in McClean, VA on 1198 Windrock Drive valued at \$1,000,000 to \$5,000,000. See Deeds in Fairfax County Clerk Office: Book 22422 Page 0586 and Book 25175 Pages 0540. See **Exhibit 2** (Note he reports no liabilities on the home)

- b. In Schedule A Cory Mills reported that he only had the following assets of cash:

Bank of America	\$15,000 to 50,000
PNC Bank	\$100,000 to 250,000

According to Schedule A Mills had between a minimum of \$115,000 and a maximum of \$300,000 yet he personally loaned his campaign over One million eight hundred forty-eight thousand nine hundred dollars (\$1,848,900). See his FEC 3 filing Summary **Exhibit 3**. He listed no other assets or liabilities that would let him loan that amount of personal cash to his campaign (see FEC reporting of Contributions and loans made to Cory Mills Campaign Committees on Exhibit 3).

- c. In Schedule A Cory Mills claims he personally owns property located at 4700 Providence Road in Perry, Florida and claims rental income from \$100,000 to \$1,000,000 on the Perry County, Florida Property. The property is owned by Pacem Estate Holdings, LLC. The property is an LLC with a registered agent in Florida in July 30, 2018 and has two other principles. See **Exhibit 4** and **Exhibit 5** of filings with Florida on official Sunbiz.org.

- d. Cory Mills did not list as assets his Florida Pacem Estate Holdings, LLC, which were acquired properties from AMTEC Less Lethal Systems, Inc in October 19, 2018. See Deed **Exhibit 6**. Mills did not list any liabilities for this LLC company. According to Deed records “the multi” property was purchased for over \$5 .5 million dollars. Is there any debt on the property? There are three properties in Perry County, Florida owned by Pacem Estate Holdings, LLC. See **Exhibit 7 Tax billing and See Exhibit 8 (5 pages) of parcels owned**. They were not reported separately on Report Schedule A of the Financial Disclosure Report.
- e. Cory Mills did not list as an asset his ALS, Inc., company which is in Taylor county, Perry, Florida and the name was changed from AMTEC Less Lethal Systems, Inc to ALS, Inc., in February 2022. See **EXHIBIT 9**. Company is located on the property owned by Pacem Estate Holdings, LLC at 4700 Providence Road, Perry, Fl. Mills did not list any liabilities for this company yet it is reported that the acquisition cost approximately \$10 million dollars in October 2018. See **Exhibit 10**. What kind of income is the company producing for Cory Mills in 2021? Were Florida Intangible Taxes paid in Florida?
- f. In Schedule A Mills claims he own 100 percent of company called Pacem Defense, LLC of Perry, Florida. There is currently no business license for that company in Taylor County, Florida.
- g. In Schedule A Cory Mills did not list companies he has his name on such as Pacem Estate Holdings, and ALS Less Lethal Systems. See Florida LLC and Corporations filings on Sunbiz.org with his name on them.
- h. In Schedule A Mills claims he owns 98 percent of Pacem Solutions International LLC of Virginia. Note that Mills is the Virginia resident who is the Corporation Registered Agent for the company according to Virginia official records and Virginia Law. Mills claims no liabilities for this company in Schedule D.
- i. In Schedule C Mills claims he was taking a salary of \$500,000 a year and his wife is taking a salary of \$300,000 per year in 2021 from Pacem Solutions International, LLC., based out of an office in Falls Church, VA. Mills claims he is earning a salary of \$500,000 a year from his Pacem Solutions International LLC. Mills is the Registered Agent and the Executive Chairman of his LLC and the Articles of Incorporation of the Company show him as the sole owner See **Exhibit 11**. Instructions for the Filing of the Financial Disclosure Report require that all income from that LLC be reported as income. He left off the Report the AMTEC Less Lethal Systems, Inc (now ALS, Inc) that he owns in Florida (**See Exhibit 12**) and leaves off the income from that business also. Where does he report his taxes to which State? Federal Contracts databases show that contracts are being awarded to Pacem Solutions International, LLC and being performed by AMTEC Less Lethal Systems, Inc. According to Federal Reporting of Contract awards Mills company has only received \$360,000 in contracts in 2021 and \$680,000 the previous year. - j. Do Virginia State and Federal business Tax Records show his earnings sources that support his May 7, 2021 Financial Disclosure Report Filing?
  - k. In Schedule D Mills does not list any mortgages or liabilities for the house he lives in at 1198 Windrock Drive, McClean, VA. Valued at over \$4 million dollars. See Deed Numbers from Fairfax County Clerk of the Court, Tax records, and Property Appraisers offices. Deeded in September 5, 2017. See Fairfax County, Virginia Property records Book 22422 Page 0586 and Book 25175 Pages 0540.
  - l. Mills did not list any of the liabilities of the companies that he claims he partially owns.
  - m. Mills did not disclose his personal Campaign loans made to his campaign.
  - n. Cory Mills shows no assets or liabilities of how he was able to loan his campaign over \$1.8 million dollars in 2021 and 2022 when he has much much less than that as he reported on Schedule A of the Financial Disclosure Report.
  - o. In Schedule E Mills deliberately left off Positions he holds in 4 different companies that he lists on Official State Corporation registrations sites in Florida See **Exhibit 13** and in Virginia See **Exhibit 14**.
  - p. He claims he owns 98 percent of the Virginia Company called PACEM Solutions International, LLC., based out of an 3<sup>rd</sup> floor office in Falls Church, VA. A deeper look into who owns the company will reveal the truth and the connection between salaries and rent from the LLCs in Virginia and Florida. Mills did not properly disclose this.
4. Cory Mills has failed to report all his assets, reported incorrectly his assets, failed to report liabilities, failed to report income from his companies, and he failed to report his positions with 4 LLCs and a Incorporation he is part owner of. Mills has deliberately filed his report knowing that the information submitted was wrong. The filing and reporting in the Financial Disclosure Report leads to more questions in the other complaints that follow.

## **Complaint 2**

1. Cory Mills has not filed a Financial Disclosure Report since May 7, 2021. He has not asked for a 90-day extension. As of this date he has refused to file his required report.
2. Mills has been a candidate for Congress for over a year since his last filing.
3. Mills is violating Federal Law by not filing the form.

### Complaint 3

1. According to Government records Cory Mills received \$1,026,300 for AMTEC Less Lethal Systems, Inc in April 2020 from the PPP program through Atlantic Union Bank. The loan was made in Falls Church, Virginia, but the principal place of Business is in Perry, Florida. AMTEC Less Lethal Systems, Inc., mailing address in Falls Church, VA received a Paycheck Protection Loan of \$1.03M through Atlantic Union Bank, which was approved in April, 2020. This loan's status is reported by the SBA as "Paid in Full", which includes both loans repaid and those fully forgiven from repayment under PPP guidelines. The loan's status was last updated by the SBA in March, 2021. AMTEC Less Lethal Systems, Inc. changed the name to ALS, Inc. later in 2020 according to Florida Corporation records and the office moved its address from the 3<sup>rd</sup> floor to a new address on the 5<sup>th</sup> floor.
2. Mills received another \$173,000 in PPP loans in April 2020 for Pacem Solutions International, LLC. The SBA loan was forgiven or paid? Where did he spend the money? Pacem Solution International LLC in Falls Church, VA received a Paycheck Protection Loan of \$173,000 through Atlantic Union Bank, which was approved in April, 2020. This loan's status is reported by the SBA as "Paid in Full", which includes both loans repaid and those fully forgiven from repayment under PPP guidelines. The loan's status was last updated by the SBA in May, 2021. The size of company's PPP loan indicates that the number of employees on payroll during the eligibility calculation period (typically 2019) was higher than the 8 jobs reported as retained on the PPP application. This could be caused by a reduction in employment since 2019, due to Coronavirus or other factors. The minimum number of employees this company must have had in 2019 to qualify for the loan range received is 8. This estimation is accurate if all employees were paid at or over the \$100k PPP salary eligibility cap. (Note that Cory Mills and his spouse say they earned \$800,000 in salary in 2020 and in 2021) Based on the standard PPP eligibility formula, it may be possible to estimate the payroll expenses represented by a company on their PPP application. In order to qualify for the PPP loan amount received, Pacem Solution International LLC's 2019 payroll expenses are estimated to be at least \$830,400 (not accounting for salary amounts > \$100k).
3. The PPP Loans were made by the same Bank and given to companies with the same Mailing Address, but the principal places of business were in different states. I request that an audit be done on the loan applications, and on the use of the money.

### Complaint 4

1. According to Federal Elections Contributions made by Cory Mills to the Laura Loomer's campaign in March and April 2022 he made contributions using an address of a multi residential high rise in Orlando, Florida. He claims he lived in the high rise yet there is no record of him or a business at that location and neither was a specific legal address specified.
2. Mills exceeded the maximum contribution of \$2,900.

## Complaint 5

Cory Mills filed with the State of Virginia and with the State of Florida that he is the Chairman and owner of LLCs and has a Corporation in Florida that all sell services and products to the Federal Government. Pacem Solutions International LLC is filed as an LLC in Virginia and according to published data in Federal Websites, they have current contracts with the United States Government with different Government Agencies.

Cory Mills has, as owner of these companies that have Federal Contracts, contributed donations to a Federal Candidate, Laura Loomer. Cory Mills is still listed on Corporation filings in both Virginia and Florida as owner of the companies that have Federal Contracts. In 2021, PACEM Solutions International, LLC and work was done in Perry, Florida on contracts awarded from the Departments of Justice and Interior worth more than \$360,000, including for work in the Federal Bureau of Prisons, according to federal records. The year before that it earned more than \$680,000 for work with the same agencies and the Department of Homeland Security, the federal records show.

PACEM Solutions International LLC owned by Mills is claimed to be registered to work in Pakistan, the United Arab Emirates, Iraq, Kenya, Malaysia and Kuwait, according to Mills' former LinkedIn profile, which was recently taken down. It has also provided what it calls "support and advisory" services to authorities in Iraq, Ukraine, Pakistan, the Democratic Republic of Congo, the Kurdish region, Malaysia and other countries. Copies of the LinkedIn profile are saved. And available.

### SUMMARY OF COMPLAINTS 1 thru 5

Cory Mills has failed to file his May 2022 Financial Disclosure Report with the Clerk of Congress as required by Federal law. This filing is required by Federal law for Candidates running for Federal Office.

On his May 2021 Financial Disclosure Report Cory Mills claims to have had only a maximum of \$315,000 in cash in 2021, yet he personally donated \$641,000 to his campaign in 2021 and another Million plus dollars in 2022 for a total of \$1,848,908. He shows no liabilities of borrowing any money on his Financial Disclosure Report. Where did he get the money from?

Cory Mills claims to own property at 4700 Providence Rd, Perry, Taylor County, Florida but Official Taylor County Property and Tax records do not show him owning the property with a County Tax bill going to him.

Cory Mills claims he owns 100 percent of Pacem Defense, LLC of Perry, Fl. There is no such business in Taylor County, Perry, Florida listed in Tax records as a business in that county. There is however a

Pacem Defense, LLC filed with the Florida Department of State and listed as a foreign corporation with his name on it with others.

Cory Mills fails to list his AMTEC Less Lethal Systems, Inc (later changed name to ALS, Inc Company) on Schedule A as a asset. He is named in the Florida Department of State in Sunbiz.org official records as part of that company, yet he failed to report it on his Financial Disclosure Report.

Cory Mills had outstanding PPP loans with 2 of his companies that were not reported on his Financial Disclosure Report. The loans were forgiven at some point but what did he do with the money?

I believe that an Audit of Cory Mills Federal and Virginia Income Tax returns will reveal the true sources of his income he used to personally loan his campaign \$1.8 million with and where he claims to have lived in 2021 and 2022.

I also believe that an audit of his companies from 2014 as to where the source of over \$11 to 16 million came from when his company just started in a 1 bedroom rental apartment between March 2014 in Arlington, VA and then in November 2015 he moved the principle place of business to a 3 bedroom townhouse in Chantilly, VA., and from there in 2018 after being reinstated by the Virginia Corporation Commission to a rented Office Suite on the 5<sup>th</sup> floor of a commercial building with according to reports may have had 8 employees. From these residences by 2018 Mills had enough money to purchase a \$4.7 million home and a \$10 million dollar Company and divided the land it was on with a \$5.5 million dollar purchase according to Tax Deeds and then in just 2 years later he has another \$1.8 million of cash to loan his Congressional Campaign without reporting any liabilities on his Congressional Financial Report he filed in May 2021. In 2020 Mills then moved his 5<sup>th</sup> floor office to the 3<sup>rd</sup> floor after receiving the PPP loans in 2020 and currently rents a small 5<sup>th</sup> floor suite in Falls Church, Virginia when he lists himself as the Registered agent, resident of Virginia and the Chair (owner) of the LLCs he filed in Virginia and Florida. According to Federal websites and commercial websites that track all contracts and subcontracts awarded to these companies from Government entities it raises many questions as to where his huge sum of money came from in such a short period of time. Even CEOs of large multibillion-dollar earnings do not earn such large salaries in such a short time. I believe that a deep dive into his contracts especially those with foreign entities that he claims his company has business dealings with is needed. And moreover, Mills has embellished and lied on his campaign literature, website and LinkedIn profile about his Army record, medals (lack thereof) and his so-called service with the State Department, USAID and JSOC service.

I seriously request that a full investigation into all these matters be done and actions taken.

I confirm that I did not obtain any of these facts illegally, and not thru any official contacts of the agencies that I worked for in the past (I did however use some public sites to obtain information legally).

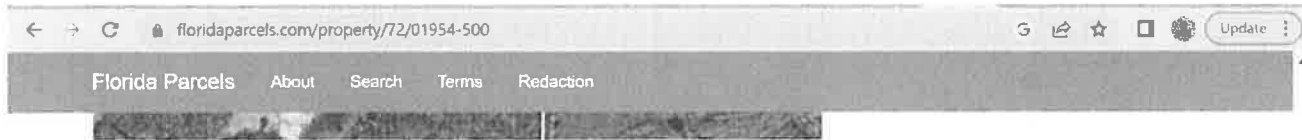

PACEM has the contacts needed to take ALS to that next level. The acquisition provides PACEM an instant manufacturing facility with an established customer base.” Although it occurred subsequent to the end of National Presto Industries, Inc.’s third quarter, the transaction will result in a third quarter impairment charge to earnings of approximately \$3 million.

National Presto Industries, Inc. operates in two business segments. If the allegations in the complaint are based in whole or in part upon information contained in an advertisement, news article, or website, the complaint should provide a copy of the relevant advertisement, news article, or link to the website, if possible. Complaints should be filed as soon as possible after the alleged violation becomes known to the complainant in order to preserve evidence and the Commission's ability to seek civil penalties in federal district court within the five-year statutes of limitations period (measured from the time of the violation) provided by 28 U.S.C. § 2462 (civil) and 2 U.S.C. § 455 (criminal).
