Cory Mills contributed \$750 on 2/10/2022, which was properly recorded for the General Election of 2022.

Laura Loomer did not win her primary in August, 2022, and a refund check was issued to Cory Mills for \$750, designated as a general election refund, in early September 2022. The refund was properly reported on the Committee's FEC report.

Along with this letter is a copy of the check mailed to Mr. Mills, as well as the refund record, as downloaded from the FEC records search feature of their website.
