After speculating that my clients must be stuffing cash into Congresswoman Hoyle's pocket, he admitted that he didn't really know whether Ms. Cazares or Mr. Mitchell made any of their contributions to the Val Hoyle for Congress Committee in cash. He had no evidence in June to support his false accusation and has provided none in support of his recent complaint to the FEC.
