Subject: CERTIFICATION FOR PAYMENT OF PRESIDENTIAL
PRIMARY MATCHING FUNDS

The Audit Division received the matching fund submission #1 from Mike Pence/Mike Pence for President on July 3, 2024. Based on the review of this submission, the Audit staff identified \$714,268.47 as matchable. Because the first regular matching fund submission includes the contributions from the threshold submission, this amount must be reduced by the amount previously certified, \$100,000. Therefore, the Audit staff recommends the Commission certify to the Secretary of Treasury a payment of \$614,268.47 from the Presidential Election Campaign Fund (PECF).
